Whether or not the club should sell its belongings and go out of existence was seriously debated at a meeting held on Saturday night last, and, while several schemes for putting new life into the club were propounded by the members present, the outlook was by all acknowledged to be

president of the club, introduced the incoming officers.

In his farewell speech he stated that the club was heavily in debt, that the membership was falling off, and that unless some means were devised to get in new members or raise funds by other means to pay off the indebtedness the club must go to the wall. He stated that the club was in debt to an Oakland bank to the extent of \$3000, which would soon fall due, and that this must be met at all hazards.


