& the other half belonging to John Cox, which 150 acres John Bolton by deed dated 2 Oct 1694 granted to me. Signed Charles Crow on 1 Aug 1714. Delivered in the presence of John Ogle & Elston Wallis. Recorded 20 Apr 1727. (H1:129).

Deed. On 11 Oct 1726 Jacob Vandevier of the county of Salem in the province of West New Jersey, yeoman to Phillip Vandevier of Brandywine Hundred, husbandman. Jacob Vandevier for £6 granted to Phillip Vandevier half of all right, estate, interest & demand that I, Jacob Vandevier had or ought to have by virtue of the will of my father, Jacob Vandevier, dec., late of Brandywine Hundred. I, Jacob Vandivier appoint my trusty friend Charles Springer, Esq. my attorney. Signed Jacob Vandevier. Delivered in the presence of John Eaton, Jacobus Vandevier & Cornelius Cornelius. Recorded 21 Apr 1727. (H1:130).

Deed. Robert Morton of Appoquinimink Creek for valuable consideration granted to William Grant all my right & interest in a tract of land lying on the south side of Appoquinimink Creek granted to me by patent from Francis Loveless by patent dated 16 June 1671 for 550 acres of upland & marsh. Signed Robert Morton on 31 Oct 1674. Delivered in the presence of Sarah Ebell & John Vaughton. Recorded 20 Apr 1727. (H1:131).

Deed. John Grant of Little Egg Harbor in the county of Burlington in West New Jersey, yeoman am firmly bound to Danjell Corbett of St. George's for the sum of £1000, which said payment to be made. Signed 24 June 1723, the condition of this obligation is such that John Grant shall cause to be made over to Danjell Corbet a deed for a tract of land on the south side of Appoquinimink Creek containing 250 acres where Anthony Duschene now dwells. Signed John Grant. Delivered in the presence of Alexander Mode & Francis Taylor. Recorded 21 Apr 1727. (H1:131).

Deed. On 20 & 21 Oct 1718 Benjamin Allmond of Black Bird's Creek, yeoman to John Vardiman of Appoquinimink, yeoman. Benjamin Allmond for £3 granted to John Vardiman a parcel of land lying of the north side of the main branch of Black Bird Creek bounded by other land of Benjamin Allmond containing 55 acres being part of a larger tract containing 1200 acres formerly taken up by Percival Westerdale, John Barker, John [blank], James Williams & Edmund Williams by patent granted to them by Edmund Andres, Governor General of the province of New York, dated 15 Jan 1675 which Benjamin Allmond purchased his tract of land from Edmund Williams by deed dated 11 June 1712. Signed Benjamin Allmond. Delivered in the presence of Fleetwood Dakeyne & George Dakeyne. Recorded 24 Apr 1727. (H1:132).
